Establishment of Anti Ragging Committee

As per AICTE regulation on curbing the menace of Ragging in Higher Educational institutions 2009, hereinafter called the "Regulations") what is Ragging? "Any Conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or junior student."

Ragging is a Social Crime. As per above referred AICTE "Regulations", Ragging is strictly prohibited in the College Campus as well as outside the College Campus. All students are here by informed not to indulge in any kind of Ragging activity either directly or indirectly. A strict action as per AICTE "Regulations" will be taken.
